# Ethics in Policing and Interpersonal Relations: Police Officer and Supervisor Liability

**MCOLES 2024 CPE (Commission Designated), Legal Liability, and Legal Updates:** This one-day course will provide police personnel at all levels and rank with an overview of the legal liability they face for their agency and individually, whether at the officer or supervisor level.
